## Rector's order n. 03/2022 Determining the organization and conditions of operation at the student dormitories and canteens of SUA Nitra from 26<sup>th</sup> February 2022

In accordance with the current pandemic situation and with regard to the currently valid measures and decisions of the Public Health Authority of the Slovak Republic, I issue the following

## order of rector

for the organization and conditions of operation at student dormitories of SUA in Nitra (hereinafter referred to as "ŠDaJ" or "accommodation facility") valid from 26.2.2022.

- 1. The aim is to maintain a safe environment in the accommodation facilities for the duration of the COVID-19 pandemic (hereinafter referred to as "COVID-19"), to establish the basic operating conditions at "ŠDaJ", including the specifics of compliance with anti-epidemic measures and recommendations. Measures to ensure safe accommodation at SUA accommodation facilities in Nitra is also the basis for ensuring full-time teaching.
- 2. With effect from **26.02.2022**, all "ŠDaJ" SUA facilities in Nitra will be in the running in the mode **BASE**.
- 3. With effect from 26.02.2022 I cancel the **Monitoring and Coordination Board of ŠdaJ** at **SUA in Nitra**.
- 4. I impose the obligation to ensure the publication of the Instructions for Accommodation at "ŠDaJ" of SUA in Nitra for the summer semester of the academic year 2021/2022 on the university and "ŠDaJ" websites, as well as in the "ŠDaJ" premises.
- 5. I impose the obligation to ensure that students are informed about current SUA measures implemented in order to ensure a safe environment and minimize the risk of infection on campus. A notice will be published in the entrance areas of the "ŠDaJ", in which the accommodation of students takes place and which informs under what conditions the student can stay in the accommodation facility. You can also inform about these measures on the website, by e-mail and other standardly used communication channels.
- 6. I impose the obligation to ensure that all accommodated students and employees of the "ŠDaJ" are informed about the conditions of the organization and operation of the ŠDaJ in accordance with the valid measures and decisions of the Public Health Authority of the Slovak Republic.
- 7. In the interior of individual "ŠDaJ" buildings, the following shall continue:
  - a. it is required the overlap of the upper respiratory tract,
  - b. it is required hand disinfection when entering the "ŠDaJ",
  - c. **it is recommended** keeping a distance of 2 m from persons,
  - d. **it is recommended** complying with the ban on creating groups at the premises of "ŠDaJ",
  - e. it is required compliance with the House Rules of the "ŠDaJ",
  - f. **it is recommended** limiting visits at "ŠDaJ" premises and visits at students' rooms.
  - g. it is required monitoring own health situation,
  - h. it is required respecting and accepting the internal regulations and guidelines of

the accommodation, which take into account the current pandemic situation.

- 8. Operations of services that are not managed by "ŠDaJ" are following the current regulations of the Public Health Authority of the Slovak Republic.
- 9. I oblige accommodated students to update their contact details (address, e-mail, telephone) in the university information system (UIS).
- 10. If the student, employee, or another accommodated person shows symptoms of acute respiratory disease, he is obliged to immediately notify the contact person of SUA in Nitra (Ing. Miroslava Cigáňová, tel.: +421 908 293 784, e-mail: miroslava.ciganova@uniag.sk). Subsequently, it is recommended to pass the test for COVID-19, the result of the test must be reported to the contact person.

- 12. Accommodation of foreign students, visitors, guests and other accommodated persons at the "ŠDaJ" is governed by the House Rules.
- 13. I impose the obligation to continue to ensure thorough cleaning of the premises of the "ŠDaJ" as a prevention of the spread of the COVID-19 disease according to the guidelines of the Public Health Authority of the Slovak Republic. Provide hand disinfection facilities at least at the entrances of individual buildings. Increase cleaning and disinfection intervals based on the risk of infection and high-frequency sites.

## Final provisions

- 1. This order will be valid and come into effect from 26. 2. 2022.
- 2. This order cancels the rector's order no. 7/2021.
- 3. Failure to comply with the provisions of this order will be considered a serious breach of accommodation regulations or work discipline of employees.
